2. Original BL and commercial invoice required for TP processing
3. Haulage Costs includes to LDN and Mty transportation via rail.
4. Consignee contact details required in advance for settlement of local charges at Kolkata.
5. We are accepting ICD BIRGUNJ only for rail movement. However, road movement is also acceptable with consignees risk/cost liability.
6. Container no. and seal no. should be correct in BL. Otherwise, additional amendment costs to be incurred. This may cause delay in movement.
